#### **Members**

Annual Membership Fee: USD 175 or SGD 242 (subject to applicable GST under Singapore Law)

Eligibility: Experienced executives, producers, directors, cinematographers and other members of the craft fraternity, media lawyers, distributors including anyone working in the content industry including television, film, animation, immersive media, internet, mobile and technology.

Documentation: Please submit completed application form and a recent photograph.

### Privileges:

- 10% discount on Asian Academy Creative Awards AAA GOLD PASS to the Awards ceremonies.
   Limit to 2 tickets only per Member.
